**Hon'ble Chief Minister Meghalaya reviews the ongoing
adverse weather conditions in the State**

Issues directions to all DCs

- **To be extra alert & vigilant for the next 24 hours especially for landslides and flash floods low lying areas**
- **To prevent traffic disruptions & ensure assistance to passengers**
- **To divide the Districts into Zones for effective disaster management**
- **To ensure immediate relief to the affected families**
- **To ensure the field officers to be in their respective headquarters**

Directs MeECL to restore power in the affected areas on war footing and deploy additional manpower for the same

In view of the ongoing adverse weather conditions of squally wind and heavy rainfall in the State, a review meeting was Chaired by the Hon'ble Chief Minister, Shri. Conrad K. Sangma with all the Deputy Commissioners on 30.05.2025.

Shri. Sanjay Goyal, IAS, Commissioner & Secretary, Revenue & Disaster Management Department brief the Chief Minister about the present situation in the State with respect to the preparedness measures and action taken by each district on account of the situation and calamity reports. Based on the review meeting, the districts reported incidents of landslides, flooding, water logging, trees falling, damage to infrastructure and disruption to utility lines. The IMD Regional office reported that the current situation is likely to continue till 31st May 2025.

In line with the current situation, the report of Human Lives Lost is 2 (two) in East Khasi Hills District due to landslide and drowning and 3 (three) injured as on 30.05.2025 till 7 PM.

The State Disaster Management Authority (SDMA) and District Disaster Management Authorities (DDMAs) are actively monitoring the situation, with emergency services in action.

The Hon'ble Chief Minister has directed all authorities and departments to be alert and to take necessary action to minimize the impact of the situation.

Public are also advised to be updated, prepared and take precautions to ensure safety during such events.
